AN ORDINANCE LEVUING A TAX ON ALL TAXABLE PROPERTY IN THE TOWN OF MOUNT CARMEL, TENNESSEE, SETTING THE RATES THEREOF, AND PROVIDING FOR COLLECTION OF SAID TAX.

BE IT PRDAOMED AMD EMACTED by the Board of Mayor and Aldermen of the Town of Mount Carmel, of the County of Hawkins, of the State of Tennessee:

SECTION 1. That there is hereby levied and enacted a tax on all property within the boundaries of the Town of Mount Carmel, which is taxable by Municipalities under the laws of the State of Tennessee.

SECTION 2. That the rate of said tax shall be the amount of \$0.75 seventy five cents per \$100.00 of the Hawkins County assessment.

SECTION 3. That said tax shall become a lien upon all property on and after January 10th of each year, shall become due and payable on and after October 1st, next following, shall become delinquent on and after March 1st, or the year following the date it becomes due and payable, and shall bear interest and penalties as provided by laws of the State of Tennessee pertaining to Municipal Taxes.

SECTION 4. That for purposes of said tax and determination of the amounts due the reunder the assessment made by the County Tax Assessor of Hawkins County, Tennessee, upon property within the boundaries of th Town of Mount Carmel, Tennessee, shall be used and are hereby adopted until such time as the said town may be appropriate action provide separate means of assessment, and provided that where property lying partly within the town and partly outside the town shall be assessed in one assessment by the

said County Tax Assessor without allocation of value as to the portion lying within the town, in such event, the Board of Mayor and Aldermen of the Town of Mount Carmel shall have full power and authority to determine what part of such assessed value is property allocable to property within said town.

Utilities and Carriers shall be assessed by the means and in the manner provided by State Law for assessment of such property.

SECTION 5. That the taxes herin levied shall be paid to the Recorder of the Town of Mount Carmel, Tennessee, or such other official or employee as the town may be ordinance or resolution designate.

SECTION 6. That the taxes herein levied may be xollected in the same manner as is provided for collection of delinquent Municipal Taxes by the laws of the State of Tennessee and any ordinance, or ordinances, of the Town of Mount Carmel. Tennessee.

SECTION 7. That all ordinances or parts of ordinances conflicting woth the provisions of this Ordinance are hereby repealed insofar as the same affect this Ordinance.

SECTION 8. That should any part of this Ordinance be held invalid by a court of competent jurisdiction, the remaining parts shall be severable and shall continue to be in full force and effect.

SECTION 9. That this Ordinance shall take effect and be in force from and after final passage, the public welfare requiring it.
