

ORDINANCE NO. 76

AN ORDINANCE AMENDING ORDINANCE NO. 48 WHICH PROVIDED FOR COMPENSATION FOR THE BOARD OF MAYOR AND ALDERMEN FOR THE CITY OF MOUNT CARMEL, AND SETTING THE AMOUNT THEREOF.

WHEREAS, the Board of Mayor and Aldermen of the town of Mount Carmel by Ordinance No. 48 provided for and set the amount of compensation for the Mayor and the members of the Board of Aldermen of the town of Mount Carmel at a specified rate as set out in Section 1 therein; and

WHEREAS, it appears to the said Board of Mayor and Aldermen that the rate of compensation should be increased to a sum of Fifty (\$50.00) dollars for each meeting which the Mayor shall attend of the said Board, whether a regularly scheduled meeting or a special called meeting and that the rate of compensation for each Alderman should be increased to the sum of Twenty-five (\$25.00) dollars for each meeting of the said Board which said Alderman attends, whether a regularly scheduled meeting or a special called meeting; and

WHEREAS, it appears to the said Board that such increase in compensation for the Mayor and each Alderman should be paid beginning with the first meeting of the Board of Mayor and Aldermen after the elections of the City of Mount Carmel, Tennessee are held and new members sworn in in October, 1981, which meeting is after the expiration of the terms of office of all members of the present Board of Mayor and Aldermen.

NOW, THEREFORE, BE IT ORDAINED by the Board of Mayor and Aldermen of the town of Mount Carmel, Tennessee that said Ordinance No. 48 is amended by deleting therein the words reading:

"Section 1: That the mayor and members of the Board of Aldermen of the City of Mount Carmel shall be compensated as follows:

- a. Mayor: The Mayor shall be paid \$15.00 for each meeting of the Mayor and Board of Aldermen which he attends, whether a regularly scheduled meeting or a special called meeting.
- b. Aldermen: Each aldermen shall be paid \$10.00 for each meeting of the Mayor and Board of Aldermen which he attends whether a regularly scheduled meeting or a special called meeting.

Section 2: This compensation shall be paid beginning with the first meeting of the Mayor and Board of Aldermen after the City Elections are held and new members sworn, in October, 1974, which meeting is after the expiration of the terms of office of all of the members of the present Board of Mayor and Aldermen." and by substituting the following provision in its place:

"Section 1: That the mayor and members of the Board of Aldermen of the City of Mount Carmel shall be compensated as follows:

- a. Mayor: The Mayor shall be paid Fifty (\$50.00) dollars for each meeting of the Mayor and Board of Aldermen which he attends, whether a regularly scheduled meeting or a special called meeting.
- b. Aldermen: Each alderman shall be paid Twenty-five (\$25.00) dollars for each meeting of the Mayor and Board of Aldermen which he attends, whether a regularly scheduled meeting or a special called meeting.

Section 2: This compensation shall be paid beginning with the first meeting of the Mayor and Board of Aldermen after the City Elections are held and new members sworn, in October, 1981, which meeting is after the expiration of the terms of office of

all of the members of the present Board of Mayor and Aldermen."

BE IT FURTHER ORDAINED that all remaining sections of said Ordinance No. 48 shall remain in full force and effect and that this Ordinance should be effective from and after its passage, the public welfare requiring it.
