## ORDINANCE NO.

## AN ORDINANCE TO CLOSE A PORTION OF THE RIGHT OF WAY OF MIMOSA STREET

AN ORDINANCE to close a portion of the unopened / unimproved right of way of Mimosa Street

Whereas, the unopened / unimproved right of way of Mimosa Street is not needed by the Town of Mount Carmel; and

Whereas, the Oak Grove Baptist Church owns the property on the north and south sides of the unopened / unimproved right of way of Mimosa Street proposed to be closed; and

Whereas, the property is necessary to develop the parking lot for the Oak Grove Baptist Church:

NOW THEREFORE, BE IT ORDAINED by the Board of Mayor and Aldermen of the Town of Mount Carmel, Tennessee as follows:

Section 1. That the unopened / unimproved right of way of Mimosa Street between the northeast and northwest corners of a lot described as tax map 22J, parcel 27 be closed by the Town of Mount Carmel, and the right of way relinquished to the adjoining property owners (Oak Grove Baptist Church). Straight lines will be extended in the northern direction across unopened / unimproved right of way of Mimosa Street from the northeast and northwest corners of said lot determining the portion of Mimosa Street to be closed.

Section 2. The attached Mount Carmel zoning map and Hawkins County tax map are incorporated into and made a part of this ordinance.

Section 3. This ordinance shall be effective from and after its passage, the public welfare requiring it.




