ORDINANCE NO. 264

AN ORDINANCE TO ACCEPT A RELEASE FROM VIC DAVIS CONSTRUCTION COMPANY, INC. FROM ANY AND ALL CLAIMS ARISING OUT OF THE BROOKSHIRE HILLS SEWER EXTENSION; TO RECEIVE A FINAL JUDGMENT OF THE CHANCERY COURT FOR HAWKINS COUNTY ORDERING THE DISMISSAL, WITH FULL PREJUDICE, OF THE CAUSE OF ACTION BROUGHT BY VIC DAVIS CONSTRUCTION COMPANY, INC. AGAINST THE TOWN OF MOUNT CARMEL; AND TO FIX THE EFFECTIVE DATE OF THIS ORDINANCE.

BE IT ORDAINED BY THE BOARD OF MAYOR AND ALDERMEN OF The Town of Mount Carmel, Tennessee, as follows:

SECTION I. That the Release dated August 12, 2003, executed by Vic Davis Construction, Inc. by its President, Vic Davis, is hereby accepted; and the Recorder is directed to affix a copy thereof to this Ordinance.

SECTION II. That the final judgment of the Chancery Court entered August 13, 2003, ordering the dismissal, with full prejudice, of the cause of action brought by Vic Davis Construction Company, Inc. against the Town of Mount Carmel is hereby accepted; and the Recorder is directed to affix a copy thereof to this Ordinance.

SECTION III. LEGAL STATUS PROVISIONS.

- A. <u>Conflict With Other Ordinances</u>. In case of conflict between this ordinance or any part thereof, and the whole or part of any existing or future ordinance of the Town of Mount Carmel, the most restrictive shall in all cases apply.
- B. <u>Validity</u>. If any section, clause, provision or portion of this ordinance shall be held to be in doubt or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, provision, or portion of this ordinance which is not of itself invalid or unconstitutional.
- C. <u>Effective Date</u>. This Ordinance shall become effective upon passage and publication, the public welfare requiring it.
