ORDINANCE NO. 268

AN ORDINANCE TO ADOPT VARIOUS STANDARD CODES RELATING TO INSPECTION ACTIVITIES OF THE TOWN OF MOUNT CARMEL, TENNESSEE, AND ENFORCEMENT OF BUILDING PROVISIONS AS PROVIDED IN SAID CODES.

- WHEREAS, it is the desire of the Town of Mount Carmel to adopt, in all respects, the various Standard Codes relating to amusement devices, building, fire prevention, gas, housing, mechanical, plumbing and swimming pools and
- WHEREAS, the adoption of these codes is done to facilitate proper inspection activities by the Town of Mount Carmel, Tennessee, relating to construction and to maintenance of buildings within the Town of Mount Carmel, Tennessee and relating to public safety, health, and general welfare;

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF MAYOR AND ALDERMEN OF THE TOWN OF MOUNT CARMEL, TENNESSEE that the following codes are hereby adopted by reference as though they were copied herein fully:

- B. <u>Validity</u>. If any section, clause, provision or portion of this ordinance shall be held to be in doubt or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, provision, or portion of this ordinance which is not of itself invalid or unconstitutional.
