ORDINANCE NO. 273

AN ORDINANCE TO FURTHER AMEND THE ZONING, TEXT AND MAP TO REZONE AN AREA KNOWN AS THE UNAKA AVENUE MANUFACTURING AREA PROPERTY, SITUATED IN THE 7TH CIVIL DISTRICT OF HAWKINS COUNTY; TO FIX A PENALTY FOR THE VIOLATION OF THIS ORDINANCE; AND TO FIX THE EFFECTIVE DATE OF THIS ORDINANCE.

BE IT ORDAINED BY THE BOARD OF MAYOR AND ALDERMAN AS FOLLOWS:

SECTION I.

That the zoning ordinance, text, and map, be and the same is hereby further amended to rezone the Unaka Avenue manufacturing area property, bounded on the east by Unaka Avenue, and having street addresses of 318 Main West Street and 105 Unaka Avenue, situated in the 7th Civil District of Hawkins County, from the existing B-4 Shopping District to M-1 Manufacturing District, said area to be re-zoned being further and more particularly described as follows:

BEING all of that property shown as 2003 Hawkins County Tax Map 33A Group A Parcels 4, 3 and part of 2.

AND BEING Lots 6, 7 and the northernmost fifty feet (50') of Lots 9 and 10 of the Sizemore Subdivision

AS SHOWN on a survey by Thos. M. Galloway dated February 10, 1941, and recorded on March 3, 1941, in Plat Book 1 at Page 548 and now found in Map Cabinet 1 at Envelope 139-B in the Registers Office for Hawkins County at Rogersville, Tennessee, all as more fully described on the attached sketch

SECTION II. That this ordinance shall take effect from and after the date of its passage and publication, as the law directs, the public welfare of the Town of Mount Carmel, Tennessee requiring it.


