ORDINANCE NO. 281

AN ORDINANCE TO RECLASSIFY CERTAIN TERRITORY OWNED BY FRED SMITH FROM R-1 (LOW DENSITY RESIDENTIAL) TO B-2 (ARTERIAL BUSINESS) WITHIN THE CORPORATE BOUNDARIES OF MOUNT CARMEL, TENNESSEE.

AN ORDINANCE to amend the zoning ordinance of the Town of Mount Carmel, Tennessee and all ordinances amendatory thereof.

BE IT ORDAINED, by the Board of Mayor and Aldermen of the Town of Mount Carmel, Tennessee as follows:

SECTION I. That the Mount Carmel, Tennessee Zoning ordinance map adopted and enacted as a part of said zoning ordinance be hereby amended by the reclassification of certain property from R-1 (Low Density Residential) to B-2 (Arterial Business), said property being delineated on the attached maps and more specifically described as a portion of Hawkins County Tax Map 11, Parcel 155 specifically described as follows:

BEGINNING at a point, said point being in the eastern ROW of Wolfe Lane and the northwestern corner of parcel 155, thence extend a line in an eastern direction with the northern property line of parcel 155 to a point, said point being 200 feet perpendicular from Wolfe Lane, thence extend a straight line in a generally southern direction perpendicular to and 200 feet east of Wolfe Lane to a point, said point being in the southern property line of parcel 155, thence extend a line in a generally western direction with the southern property line of parcel 155 crossing Wolfe Lane to a point, said point being in the western ROW of Wolfe Lane, thence extend a line in a generally southern direction with the western ROW of Wolfe Lane to a point, said point being the southeastern corner of parcel 155, thence extend a line in a generally western direction with the southern property line of parcel 155 to a point, said point being 200 feet perpendicular from Wolfe Lane, thence extend a straight line in a generally northern direction perpendicular to and 200 feet to the west of Wolfe Lane to a point, said point being 50 feet from the northern property line of parcel 155, thence extend a straight line in a generally eastern direction 50 feet south of and perpendicular to the northern property line of parcel 155 crossing Wolfe Lane to a point, said point being in the western ROW of Wolfe Lane, thence extend a line in a generally northern direction with the western ROW of Wolfe Lane to the point of BEGINNING.

SECTION II. The attached Mount Carmel zoning map and Hawkins County tax map are incorporated into and made a part of this ordinance.

SECTION III. This ordinance shall be effective from and after its passage and publication, as the law directs, the public welfare of the citizens of Mount Carmel, Tennessee, requiring it.




