#### **ORDINANCE NO. 293**

AN ORDINANCE TO FURTHER AMEND THE ZONING, TEXT AND MAP TO REZONE AN AREA KNOWN AS THE DOVER AVE. BUSINESS AREA PROPERTY, SITUATED IN THE 7<sup>TH</sup> CIVIL DISTRICT OF HAWKINS COUNTY; TO FIX A PENALTY FOR THE VIOLATION OF THIS ORDINANCE; AND TO FIX THE EFFECTIVE DATE OF THIS ORDINANCE.

**BE IT ORDAINED**, by the Board of Mayor and Aldermen of the Town of Mount Carmel, Tennessee as follows:

**SECTION I.** That the zoning ordinance, text, and map, be and the same is hereby further amended to rezone the Dover Ave. business area property, recently subdivided from 436 Main St., bounded on the north by Inca Drive and bounded on the south by Main Street, situated in the 7<sup>th</sup> Civil District of Hawkins County, from the existing B-2 Arterial Business District to B-3 General Business District, said area to be re-zoned being further and more particularly described as follows:

**BEING** the property shown as 2003 Hawkins County Tax Map 32D Group F Part of Parcel 8.00

AND BEING Lot 16 of the A. J. & Sallie Tranbarger Property

AS SHOWN on a Plat by Murrell Weems, surveyor, dated May 15, 2005, and recorded on July 18, 2005, in Map Cabinet 3, at Envelope 921A, in the Registers Office for Hawkins County at Rogersville, Tennessee, all as more fully described on the attached sketch.

**SECTION II.** Any person violating any provisions of this ordinance shall be guilty of an offense and upon conviction shall pay a penalty of up to FIFTY DOLLARS (\$50.00) for each offense. Each occurrence shall constitute a separate offense.

**SECTION III.** That this ordinance shall take effect from and after the date of its passage and publication, as the law directs, the public welfare of the citizens of Mount Carmel, Tennessee, requiring it.


