#### **ORDINANCE NO. 316**

AN ORDINANCE TO FURTHER AMEND THE ZONING, TEXT AND MAP TO REZONE AN AREA KNOWN AS 125 INCA DRIVE AND ADJOINING PARCEL #2.01 ON DOVER AVE. BUSINESS AREA PROPERTY, SITUATED IN THE 7<sup>TH</sup> CIVIL DISTRICT OF HAWKINS COUNTY; TO FIX A PENALTY FOR THE VIOLATION OF THIS ORDINANCE; AND TO FIX THE EFFECTIVE DATE OF THIS ORDINANCE.

**BE IT ORDAINED**, by the Board of Mayor and Aldermen of the Town of Mount Carmel, Tennessee as follows:

That the zoning ordinance, text, and map, be and the same is hereby further amended to rezone 125 Inca Drive and adjoining Parcel #2.01 on Dover Ave. business area property bounded on the north by Parcel #1, Dover Ave. and bounded on the south by Inca Drive, situated in the 7<sup>th</sup> Civil District of Hawkins County, from the existing B-2 Arterial Business District to B-3 General Business District, said area to be re-zoned being further and more particularly described as follows:

**BEING** the property shown as 2000 Hawkins County Tax Map 32D Group F Parcel 2.00 and 2.01

AND BEING Lots 33 and 35 of the A. J. & Sallie Tranbarger Property

AS SHOWN on a map by O. O. Graham, surveyor, of record in the Register's Office for Hawkins County at Rogersville, Tennessee, in Plat Cabinet 1, Envelope 38A, and being the same property conveyed to the Party of the First Part by deed dated March 13, 2006, of record in the Register's Office aforesaid in Book 799 at Page 119, to all of which reference is hereby expressly made, all as more fully described on the attached sketch.

- Any person violating any provisions of this ordinance shall be guilty of an offense and upon conviction shall pay a penalty of FIFTY DOLLARS (\$50.00) for each offense. Each occurrence shall constitute a separate offense.
- SECTION III. That this ordinance shall take effect from and after the date of its passage and publication, as the law directs, the public welfare of the Town of Mount Carmel, Tennessee, requiring it.




