## ORDINANCE NO. 319

AN ORDINANCE TO AMEND THE MOUNT CARMEL MUNICIPAL CODE TO ADD "FAILURE TO APPEAR" AS AN OFFENSE, AND TO PROVIDE A PENALTY FOR ITS VIOLATION.

WHEREAS, <u>Tennessee Code Annotated</u> § 7-63-101 provides authority for officers to write citations in lieu of arresting violators of municipal ordinances;

WHEREAS, <u>Tennessee Code Annotated</u> § 7-63-102 requires offenders to sign an agreement to appear at a time and place indicated in the citation;

WHEREAS, Under <u>Tennessee Code Annotated</u> § 7-63-105, cities may by ordinance provide that failure to appear at the agreed time and place written in the citation is punishable as a municipal offense; and

WHEREAS, the Board of Mayor and Aldermen desires to make such failure to appear an offense punishable by fine;

Now, therefore,

BE IT ORDAINED BY THE TOWN OF MOUNT CARMEL, TENNESSEE, THAT:

Section 1. Section 11-121, "Failure to appear," is added to Title 11, Chapter 1 of the Mount Carmel Municipal Code to read as follows:

- 11-121. <u>Failure to appear</u>. (1) It is a civil offense for any person in the Town of Mount Carmel who receives a citation in lieu of arrest for the violation of an ordinance, and signs an agreement and waiver as provided under <u>Tennessee Code Annotated</u> § 7-63-102, to fail to appear for trial at the time and place designated in the agreement.
- (2) Violations of this section shall subject the offender to a fine of up to fifty dollars (\$50.00) for each offense.

Section 2. Date of effect. This ordinance shall take effect from and after its final passage, the public welfare requiring it.
