#### **ORDINANCE NO. 338**

AN ORDINANCE TO AMEND TITLE 14, "ZONING AND LAND USE CONTROL"; CHAPTER 10, "AREA, YARD AND HEIGHT REQUIREMENTS"; SECTION 1001, "TABLE 1"; AND TO FIX THE EFFECTIVE DATE OF THIS ORDINANCE.

BE IT ORDAINED by the Board of Mayor and Aldermen as follows:

**SECTION I.** That the Town of Mount Carmel Municipal Code, Title 14, Zoning and Land Use Controls, Chapter 10, Area, Yard and Height Requirements, Section 14-1001, Table 1 is amended by adding a new "Note 5" and "Note 6", which said Notes shall read as follows:

Sec 14-1001. Table 1. Minimum Yard Requirements From Property Lines

NOTE 5: Setbacks for structures in the areas bounded by the railroad to the north, Main Street to the south, Hammond Avenue to the East and the Church Hill boundary line to the west are as follows:

<u>Rear setback:</u> Zero (0) feet for one (1) story structures, ten (10) feet for two (2) or more story structures;

<u>Side setback</u>: Five (5) feet; and <u>Front setback</u>: Thirty (30) feet;

EXCEPT that in the event any of real or apparent conflict or inconsistency between these setback provisions and those of any other municipal, state or federal ordinance, statute, code or regulation, that requirement which establishes the higher or stricter standard shall prevail.

NOTE 6: Setbacks for start of parking lots in the areas bounded by the railroad to the North, Main Street to the South, the corporate limits with the City of Kingsport to the East and the corporate limits with the City of Church Hill to the West are as follows: Front setback: Ten (10) foot from the edge of the pavement on Main Street for future sidewalks.

**SECTION II.** This ordinance shall take effect from and after its final passage, as the law directs, the public welfare of the Town of Mount Carmel demanding it.
