

ORDINANCE NO. 09-347

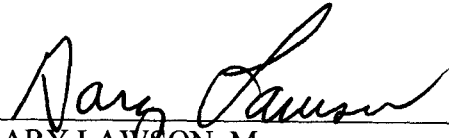
AN ORDINANCE ESTABLISHING CITY COURT COSTS

WHEREAS, the Mount Carmel Board of Mayor and Aldermen has determined that present court costs are insufficient to cover current operating expenses of the court,

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF MAYOR AND ALDERMEN OF THE TOWN OF MOUNT CARMEL, TENNESSEE, as follows:

SECTION I. In all cases heard and determined by him, the city judge shall impose court costs in the amount of \$77.25, to be added to the fine and litigation tax. One dollar (\$1.00) of the court costs shall be forwarded by the court clerk to the state treasurer to be used by the administrative office of the courts for training and continuing education courses for municipal court judges and municipal court clerks.

SECTION II. That this ordinance shall take effect from and after the date of its passage as the law directs, the public welfare requiring it.



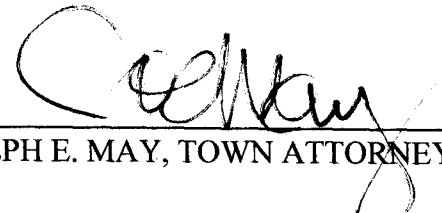
