ORDINANCE 2012-373

AN ORDINANCE TO AMEND THE CODE OF ORDINANCES BY CHANGING TITLE 13, CHAPTER 5 REGARDING THE TITLE OF SECTION 13-501 AND TO FIX THE EFFECTIVE DATE OF THIS ORDINANCE.

BE IT ORDAINED BY THE BOARD OF MAYOR AND ALDERMAN AS FOLLOWS:

SECTION I. That Title 13, Chapter 5 of the Code of Ordinances is changed as follows:

1. Index: Change the title of Section 13-501 as follows:

Current: 13-501 Owner occupied residences.

Revised: 13-501 Structures unfit for human occupation or use.

2. Change the introductory title of Section 13-501 as follows:

Current: 13-501. Owner occupied residences.

Revised: 13-501. Structures unfit for human occupation or use.

SECTION II. That this ordinance shall take effect from and after the date of its passage and publication, as the law directs, the public welfare of the Town of Mount Carmel, Tennessee requiring it.

SUBJECT: Change to Unsafe Structures Ordinance

April 17, 2012

- 1. During the start of an unsafe structure procedure, it was noticed that the title of the pertinent section of the Municipal Code had been changed when the code was republished last year. The change was not noted until now because that section had not been used or reviewed until now. The correct title needs to be made so there is no doubt of the intent if the case is subjected to judicial review.
- 2. The section should be titled as provided in state law: "Structures unfit for human occupation or use." During the rewrite the Title was changed to "Owner occupied residences" for unknown reasons.
- 3. An ordinance which contains the changed language along with the current erroneous wording is attached. The Planning Commission reviewed the proposed change and recommended approval at the April 10, 2012 meeting.
