

ORDINANCE NO. 16-437

AN ORDINANCE REPEALING ORDINANCE NO. 14-424

WHEREAS, the Board of Mayor and Aldermen of the Town of Mount Carmel, Tennessee passed Ordinance No. 14-424 upon second reading amending the storm water regulations for the Town of Mount Carmel; and

WHEREAS, the Tennessee Department of Environment and Conservation ("TDEC") recently amended their requirements for storm water system updates, significantly lessening the requirements to meet the state standard; and

WHEREAS, the more restrictive Ordinance No. 14-424 threatens to place Mount Carmel, Tennessee in a disadvantaged position when compared to nearby communities, due to the strictures imposed by the previous TDEC requirements; and

WHEREAS, the Board of Mayor and Aldermen want to ensure that Mount Carmel, Tennessee is an attractive destination for industry and business; and

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF MAYOR AND ALDERMEN OF MOUNT CARMEL, TENNESSEE AS FOLLOWS:

Section 1. Ordinance No. 14-424 is hereby repealed.

Section 2. The Board of Mayor and Aldermen shall pass an ordinance in compliance with TDEC guidelines prior to the newly stated deadline.

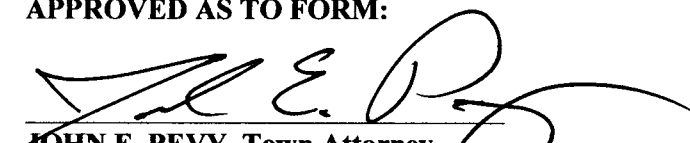

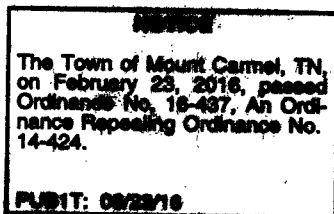
