ORDINANCE NO 18-476

AN ORDINANCE TO OPT OUT OF THE CONTINUING EDUCATION REQUIRMENTS FOR PLANNING COMMISSIONERS SET FORTH IN THE TENNESSEE CODE ANNOTATED 13-4-101.

- WHEREAS, the legislation of the State of Tennessee passed Section 13-4-101 of the Tennessee Code Annotated Creation of planning commission Compensation Appointment of members Term of office Vacancies Training and continuing education; and
- WHEREAS, Section 13-4-101 of the Tennessee Code Annotated subsection (c) (1) provides that each planning commissioner shall, within one (1) year of initial appointment and each calendar year thereafter, attend a minimum of four (4) hours of training and continuing education in one (1) or more of the subjects listed in subdivision (c) (5); and
- WHEREAS, Section 13-4-101 of the Tennessee Code Annotated subsection (c) (2) provides that each full-time or contract professional planner or other administrative official whose duties include advising the planning commission shall, each calendar year, attend a minimum of eight (8) hours of training and continuing education in one (1) or more of the subjects listed in subdivision (c) (5); and
- WHEREAS, Section 13-4-101 of the Tennessee Code Annotated subsection (c) (9) provides that the legislative body of the municipality may, at any time, opt out of the provisions of this subsection (c) by passage of an ordinance. Further any such legislative body that has opted out may, at a later date, opt in by passage of an ordinance; and
- WHEREAS, these educational requirements represent an unfunded mandate for the state that will impose a hardship on the municipality both in the expense of such training and educational requirements and in eliminating otherwise qualified people from service on the planning commission; and

NOW, THEREFORE, BE IT ORDAINED, by the Board of Mayor and Aldermen of the Town of Mount Carmel, Tennessee that as provided by 13-4-101 the Town of Mount Carmel hereby opts out of the monitory training requirements for members of the planning commission and staff members offering advisement;
