

ORDINANCE NO. 19-487 TOWN OF MOUNT CARMEL, TENNESSEE

AN ORDINANCE AMENDING THE MOUNT CARMEL LIBRARY BOARD COMPOSITION REQUIREMENTS

- WHEREAS, Mount Carmel Municipal Code provides for the appointment of a Library Board at Title 2, Chapter 3, Sections 301-303; and
- WHEREAS, the Town of Mount Carmel and the Mount Carmel Public Library Board seeks to maximize the ability build a strong and effective Library Board; and
- WHEREAS, the Town of Mount Carmel and the Mount Carmel Public Library Board seeks to assemble board composition based on the shared interest and commitment to the library; and
- WHEREAS, the Town of Mount Carmel and the Mount Carmel Public Library Board deems it necessary to select Library Board members without consideration of gender; and

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF MAYOR AND ALDERMEN OF THE TOWN OF MOUNT CARMEL, TENNESSEE AS FOLLOWS:

Section 1. Section 2-302 is hereby amended to read as follows:

2-302. Composition of the Board. Not more than (1) of the seven (7) members shall be a member of the board of mayor and aldermen. This member shall be appointed by the current Mayor and approved by the Library Board. The members shall serve without salary. Library Board members may serve for two (2) consecutive terms of three (3) years. Individuals may be appointed to fill an unexpired term, which will not count as one of the two full terms. The members shall be appointed by the mayor subject to the consent of the board of mayor and aldermen, and must all be residents of Hawkins County, Tennessee.

<u>Section 2.</u> This ordinance shall take effect upon passage, the law requiring it.

- WHEREAS, the Town of Mount Carmel and the Mount Carmel Public Library Board seeks to assemble board composition based on the shared interest and commitment to the library; and
- WHEREAS, the Town of Mount Carmel and the Mount Carmel Public Library Board deems it necessary to select Library Board members without consideration of gender; and

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF MAYOR AND ALDERMEN OF THE TOWN OF MOUNT CARMEL, TENNESSEE AS FOLLOWS:

<u>Section 1.</u> Section 2-302 is hereby amended to read as follows:

2-302. Composition of the Board. Not more than (1) of the seven (7) members shall be a member of the board of mayor and aldermen. This member shall be appointed by the current Mayor and approved by the Library Board. The members shall serve without salary. Library Board members may serve for two (2) consecutive terms of three (3) years. Individuals may be appointed to fill an unexpired term, which will not count as one of the two full terms. The members shall be appointed by the mayor subject to the consent of the board of mayor and aldermen, and must all be residents of Hawkins County, Tennessee.

Section 2. This ordinance shall take effect upon passage, the law requiring it.
