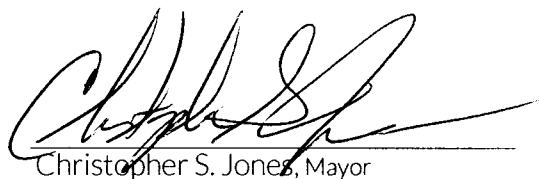
- WHEREAS, The Town of Mount Carmel Board of Mayor and Aldermen understands public confidence in local government to be of paramount importance; and

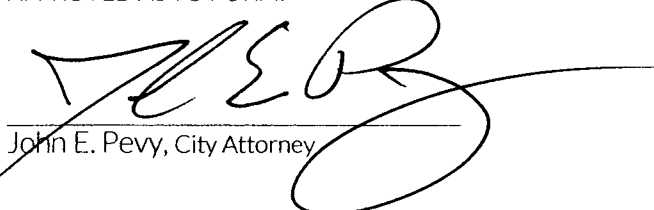
- SECTION I. The Board of Mayor and Aldermen shall convene on the second Thursday of the month at 6:30 p.m. to hold a regularly scheduled work session.

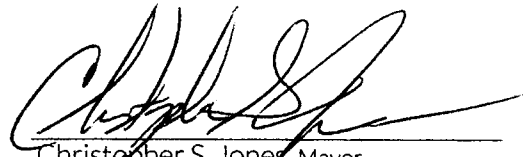
