TOWN OF MOUNT CARMEL, TENNESSEE

AN ORDINANCE OF THE TOWN OF MOUNT CARMEL TENNESSEE TO REPEAL AND REPLACE TITLE 15 "MOTOR VEHICLES TRAFFIC AND PARKING", CHAPTER 6 "PARKING" OF THE MOUNT CARMEL MUNICIPAL CODE

WHEREAS, the Town of Mount Carmel Board of Mayor and Aldermen wish to revise the Ordinance governing parking within the municipal boundaries of the Town of Mount Carmel.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF MAYOR AND ALDERMEN FOR THE TOWN OF MOUNT CARMEL TENNESSEE THAT CHANGES BE MADE AS FOLLOWS:

- Section 1. Title 15 "Motor Vehicles Traffic and Parking", Chapter 6 "Parking", is repealed in it's entirety.
- Section 2. Title 15 "Motor Vehicles Traffic and Parking", Chapter 6 "Parking", is replaced with the following:

No parking is allowed on the paved portion of any street within the Town of Mount Carmel except in the event of extreme inclement weather conditions. Temporary parking permits may be issued at the discretion of the Chief of Police in order to accommodate other temporary on street parking due to exigent circumstances.

Section 3. If any provision herein should conflict with other provisions of the Mount Carmel Code of Ordinances the most restrictive provisions shall apply.

This Ordinance shall take effect immediately upon final passage and publication, the public welfare requiring it.
