TOWN OF MOUNT CARMEL, TENNESSEE

AN ORDINANCE OF THE TOWN OF MOUNT CARMEL TENNESSEE AMENDING  
THE FISCAL YEAR 2022-2023 PASSED BY ORDINANCE NO. 22-511

- WHEREAS the Town of Mount Carmel adopted the fiscal year 2022-2023 Budget by passage of Ordinance No. 22-511 on June 24, 2022; and
- WHEREAS the Tennessee state constitution, Section 24 of Article II, no public money shall be expended except pursuant to appropriations made by law; and
- WHEREAS pursuant to the Municipal Budget Law of 1982, as found in the *Tennessee Code Annotated* §6-56-209, the Board of Mayor and Aldermen has the authority to authorize the budget officer to transfer moneys from one appropriation to another within the same fund; and
- WHEREAS Local sales tax revenues for the General Fund will be greater than anticipated; and
- WHEREAS Expenses for Recreation Department and State Street Aid will be greater than anticipated; and
- WHEREAS Sales tax revenues are housed within the General Fund for the Town;
- WHEREAS The expenses for Parks and Recreation and State Street Aid are housed within the General Fund for the Town;

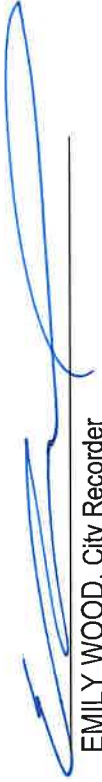
NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF MAYOR AND ALDERMEN FOR THE TOWN OF MOUNT CARMEL, TENNESSEE THAT CHANGES BE MADE TO THE FISCAL YEAR 22-23 BUDGET AS FOLLOWS:

SECTION 1. Ordinance No. 22-511 is hereby amended by increasing Recreation expenditures by \$40,000; increasing State Street Aid expenditures by \$50,000; and by increasing Miscellaneous Revenue by \$90,000;

SECTION 2. The Board of Mayor and Aldermen authorizes the City Recorder to make said changes in the accounting system

SECTION 3. This Ordinance shall take effect immediately upon final passage.
