RESOLUTION ADOPTING TOWN OF MOUNT CARMEL, TENNESSEE
POLICE DEPARTMENT POLICIES AND PROCEDURES

WHEREAS, MOUNT CARMEL MUNICIPAL CODE TITLE 6 "LAW ENFORCEMENT"
CHAPTER 1 "POLICE AND ARREST" PROVIDES THAT ALL POLICEMEN ARE TO OBEY
AND COMPLY WITH SUCH ORDERS AND ADMINISTRATIVE RULES AND REGULATIONS
AS THE POLICE CHIEF MAY OFFICALLY ISSUE; AND

WHEREAS, THE TENNESSEE MUNICIPAL LEAGUE RISK MANAGEMENT POOL RECOMMENDS
THE ADOPTION OF A POLICIES AND PROCEDURES MANUAL FOR THE PURPOSE OF
BEST PROTECTING BOTH POLICEMEN AND THE MUNICIPALITY FROM LIABILITY;
and

WHEREAS, THE ADOPTION OF A UNIFORM POLICIES AND PROCEDURES MANUAL
WILL MAKE THE OPERATIONS OF THE POLICE DEPARTMENT MORE EFFICIENT AND
EFFECTIVE; AND

WHEREAS, THE HEALTH, SAFETY, AND WELFARE OF THE CITIZENS AND INHABITANTS
OF THE TOWN OF MOUNT CARMEL WOULD BEST BE SERVED BY THE ADOPTION OF
UNIFORM POLICIES AND PROCEDURES;


NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF MAYOR AND ALDERMEN
OF THE TOWN OF MOUNT CARMEL:

1. THE ATTACHED TOWN OF MOUNT CARMEL, TENNESSEE, POLICE DEPARTMENT
POLICIES AND PROCEDURES SHOULD BE AND IS HEREBY ADOPTED AS THE OFFICIAL
POLICY OF THE TOWN OF MOUNT CARMEL IN REGARD TO ALL MATTERS CONTAINED
THEREIN;

2. ALL POLICE OFFICERS, WHETHER FULL-TIME, PART-TIME, REGULAR,
AUXILLARY, OR OTHERWISE SHALL BE ISSUED A NUMBERED COPY OF THE ATTACHED
POLICIES AND PROCEDURES MANUAL. SAID MANUAL IS TO BE CONSIDERED PROPERTY
OF THE DEPARTMENT AND UPON THE SEVERENCE OF TIES BETWEEN SAID OFFICER
AND THE DEPARTMENT THE MANUAL IS TO BE RETURNED TO THE DEPARTMENT AS
DEPARTMENTAL PROPERTY:


3. ALL OF THE MATTERS CONTAINED IN THE ATTACHED POLICIES AND PROCEDURES MANUAL IS CONSIDERED TO BE PROPRIETARY AND UNLESS DISSEMINATION OF A SPECIFIC PORTION TO THE PUBLIC IS CALLED FOR EACH OFFICER SHOULD CONSIDER THE INFORMATION THEREIN AS PROPRIETARY AND SHOULD PROTECT THE TOWN'S INTEREST FROM SAME:
