

RESOLUTION NO. 221

A RESOLUTION REVISING AND UPDATING RESOLUTION NO. 217: A MERIT PAY PLAN FOR MOUNT CARMEL EMPLOYEES.

WHEREAS, the Board of Mayor and Aldermen adopted Resolution No. 217 on June 22, 2000; and

WHEREAS, Resolution No. 217 initiated a Merit Pay plan for Mount Carmel employees; and

WHEREAS, there is a need to revise and update the Merit Pay Plan in several respects, namely;

1. Add position of Detective, Range N
2. Increase City Recorder from Range N to Range O
3. Increase Assistant Chief of Police from Range M to Range O
4. Add position of Patrol Lieutenant, Range M
5. Add Assistant Superintendent, Wastewater, Range M
6. Add Utility Operator without diploma or G.E.D., Range F
7. Add Utility Operator with diploma or G.E.D., Range G
8. Add Mechanic, Range K; and

WHEREAS, these revisions and updates will more closely follow the pay ranges offered by towns in our immediate area and allow and encourage our employees to gain new skills and abilities and thereby improve the services to our citizens;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF MAYOR AND ALDERMEN OF THE TOWN OF MOUNT CARMEL, TENNESSEE, as follows:

SECTION I. The attached Pay Schedule dated: Effective September 3, 2000, is hereby adopted.

SECTION II. The Pay Schedule dated June 5, 2000, is hereby rescinded.

SECTION III. This Resolution shall take effect on September 3, 2000.
