RESOLUTION NO. 230

**RESOLUTION RESCINDING RESOLUTIONS NUMBERED
200 AND 201 AND RECOMMENDING URBAN GROWTH
PLAN FOR THE TOWN OF MOUNT CARMEL**

Whereas, the Board of Mayor and Aldermen adopted Resolution 200 on December 9, 1999, and Resolution 201 on February 24, 2000, which recommended Urban Growth Boundaries under the provisions of Public Chapter 1101 of the Laws of the State of Tennessee to the Hawkins County Coordinating Committee; and

Whereas, the Board of Mayor and Aldermen have reevaluated the long term consequences to the future of the Town if the Urban Growth Boundaries as recommended are too restrictive; and

Whereas, the Town has limited room to grow and expand its services to future residents of areas close to the Town's present boundaries; and

Whereas, future residents of areas close to the Town's boundaries will be prohibited from receiving any of the services the Town provides its citizens, unless and until the Urban Growth Boundaries are established in a more rational manner, allowing for future development of residential and commercial neighborhoods near the Town; and

Whereas, it is in the best interest of the citizens of the Town of Mount Carmel, Tennessee and citizens and businesses of Hawkins County, Tennessee, living and operating in close proximity to existing corporate boundaries, to establish more rational and forward-looking Urban Growth Boundaries; and

Whereas, the Hawkins County Coordinating Committee has adopted a county-wide plan too restrictive for the best interests of the Town.

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF MAYOR AND ALDERMEN OF THE TOWN OF MOUNT CARMEL, TENNESSEE, as follows:

Section 1. That Resolution 200, adopted December 9, 1999, and Resolution 201, adopted February 24, 2000, are hereby rescinded.

Section 2. That Urban Growth Boundaries, as indicated on a map contained in Mount Carmel, Tennessee Urban Growth Boundary Report dated December 1999, are hereby recommended to the Hawkins County Coordinating Committee and are the officially requested boundaries of the Town of Mount Carmel as provided for by Public Chapter 1101 of the laws of the State of Tennessee.

Section 3. This Resolution shall take effect upon its passage, as the law requires.
